Important Information

General Info

- A deposit of \$150 per camper per session is required and must accompany this registration form.
- A registration can not be processed without a full deposit plus a payment plan or payment in full for all fees due at the time of registration.
- Membership dues and non-member fees must be current throughout the length of camp sessions.
- Membership is an annual purchase. In situations where the program end date exceeds the current membership expiration date the membership must be renewed for an additional year.
- Your JCC account must be current to register for camp. Delinquent balances must be paid in full or payment arrangements made before any new registrations are accepted.
- Financial assistance is available to those who qualify. For a confidential application, please call Financial Assistance Administrator, at (412) 521-8011, ext. 200.
- Camp must be paid in full no later than May 20, 2012. All discounts will revert back to regular rate if not paid in full by May 20, 2012.
- Failure to meet payment schedules will result in loss of all pre-early bird, early bird and membership discounts.
- Non-member fees will be applied to all camp registrations. To qualify as a non-member, primary residence must be more than 10 miles from the JCC.
- The JCC reserves the right to cancel any camp due to insufficient enrollment. The JCC will issue you a full refund if a camp program is cancelled.
- If your child does not complete the session at Camp's request, no refunds will be issued.
- There are no refunds or credits due to illness or absence.
- Registrations received after May 20th must be paid in full.
- Camper photos and comments may be used for publicity without compensation or prior consent.
- Camp fees are non-transferable.

Additional Fees

- Cancellations prior to April 1st will be refunded in full. Cancellations prior to May 1st will be refunded less \$150 per child per session. Cancellations beginning May 1st will receive no refunds or credits.
- Non Member Fees: vary between \$75 and \$150 per session, dependent upon length of session. Must live more than 10 miles from the JCC to qualify for non-member rate.
- \$25 service charge for returned checks, insufficient funds, and rejected credit cards.

Discounts

- \$50 *sibling discount* off of the total fee for each additional sibling registered (four weeks or more).
- \$50 *pay in full discount* will be applied to the total balance of each camp registration (four weeks or more) for all payments made in full at the time of registration through May 20th.
